A RESOLUTION

Respectfully requesting the United Nations to terminate the Strategic Trusteeship for the Trust Territory of the Pacific Islands upon approval of the Compact of Free Association by the United States Congress.

1 WHEREAS, on October 1, 1982, the Government of the Federated States  
2 of Micronesia and the Government of the United States of America executed  
3 the Compact of Free Association and several related agreements; and

4 WHEREAS, on June 21, 1983, a plebiscite on future political status  
5 was held in the Federated States of Micronesia, in accordance with the  
6 provisions of Public Law No. 2-54 and sections 411 and 412 of the Compact  
7 of Free Association; and

8 WHEREAS, on July 13, 1983, the President of the Federated States of  
9 Micronesia determined, based on the certification of the final results  
10 made by the Plebiscite Commission which was established by Public Law  
11 No. 2-54, that a majority of the ballots validly cast in the plebiscite  
12 were in favor of approving the Compact of Free Association and its related  
13 agreements; and

14 WHEREAS, on September 2, 1983, the President issued a proclamation  
15 stating that he had determined that the Compact of Free Association and  
16 its related agreements had been approved by a majority in the legislatures  
17 of two-thirds of the States of the Federated States of Micronesia as  
18 required by section 4 of article IX of the Constitution of the Federated  
19 States of Micronesia; and

20 WHEREAS, the Congress of the Federated States of Micronesia on  
21 September 2, 1983, ratified the Compact of Free Association and its  
22 related agreements as required by section 4 of article IX of the  
23 Constitution of the Federated States of Micronesia; and

24 WHEREAS, the Compact of Free Association and its related agreements  
25 are presently before the United States Congress for approval; and


1 WHEREAS, there is a clear and distinct likelihood that the United  
2 States Congress may approve the Compact of Free Association and its  
3 related agreements sometime within the next calendar year; and

4 WHEREAS, upon approval of the Compact of Free Association and its  
5 related agreements by the United States Congress, in order for the Federated  
6 States of Micronesia to truly join the international rank of nations, the  
7 Strategic Trusteeship for the Trust Territory of the Pacific Islands should  
8 be terminated; now, therefore,

9 BE IT RESOLVED by the Third Congress of the Federated States of Micro-  
10 nesia, Third Special Session, 1984, that the Congress respectfully requests  
11 the United Nations to terminate the Strategic Trusteeship for the Trust  
12 Territory of the Pacific Islands upon approval of the Compact of Free  
13 Association and its related agreements by the United States Congress; and

14 BE IT FURTHER RESOLVED that certified copies of this resolution be  
15 transmitted to the Secretary-General of the United Nations and the  
16 President of the Federated States of Micronesia.
