A RESOLUTION

Calling for a Fourth Special Session of the Third Congress of the Federated States of Micronesia, to be convened at a date and for a duration to be set by the Presiding Officer during either the month of December 1984 or the first 2 weeks of January 1985.

- WHEREAS, the Third Congress of the Federated States of Micronesia
- 2 is nearing the end of its Fourth and final Regular Session; and
- 3 WHEREAS, the National Plan Task Force has indicated that the final
- 4 draft of the National Overall Economic Development Plan will be
- 5 transmitted to the Congress for approval at or near the end of the
- 6 Fourth Regular Session; and
- 7 WHEREAS, after said transmittal of the National Plan to the
- 8 Congress, sufficient time to carefully analyze the document will be
- 9 required; and
- 10 WHEREAS, after said congressional analysis is completed, the
- 11 Congress must meet in formal session in order to vote on approval of
- 12 the National Plan; and
- 13 WHEREAS, there are other important matters which the Congress may
- 14 not be able to address during the remaining days of the Fourth Regular
- 15 Session, and which could be taken up in special session; and
- 16 WHEREAS, it is the sense of the Congress that an appropriate time
- 17 to hold a special session would be either sometime in the month of
- 18 December 1984 or sometime in the first 2 weeks of January 1985; and
- 19 WHEREAS, section 16 of article IX of the Constitution of the
- 20 Federated States of Micronesia provides that a special session may be
- 21 convened at the call of the President of the Federated States of Micronesia
- 22 or by the Presiding Officer of the Congress on the written request of
- 23 two-thirds of the Members; now, therefore,
- BE IT RESOLVED by the Third Congress of the Federated States of
- 25 Micronesia, Fourth Regular Session, 1984, with the concurrence of

two-thirds of the Members, that a Fourth Special Session of the Third Congress of the Federated States of Micronesia be convened by the Presiding Officer during either sometime in the month of December 1984 or sometime during the first 2 weeks of January 1985; and BE IT FURTHER RESOLVED that the Congress hereby authorizes the Speaker, as Presiding Officer, to set the specific date upon which said 7 Fourth Special Session will convene, and to further set the duration of said Fourth Special Session; and BE IT FURTHER RESOLVED that certified copies of this resolution be 10 transmitted to the Speaker of the Congress of the Federated States of 11 Micronesia, the President of the Federated States of Micronesia, and the 12 Governors and Speakers of the State legislatures in each of the States 13 of the Federated States of Micronesia. 14 Date: 10.31-84 Introduced by: John R.
