A BILL FOR AN ACT

To appropriate the sum of \$199,800 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, for the purpose of funding the construction of farm access roads on the nine high islands of Truk, including Tol, Polle, Patla, Wonei, Udot, Fefan, Uman, Dublon, and Moen, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$199,800, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the Federated
- 3 States of Micronesia for the fiscal year ending September 30, 1986,
- 4 for the purpose of funding the construction of farm access roads on the
- 5 nine high islands of Truk, including Tol, Polle, Patla, Wonei, Udot,
- 6 Fefan, Uman, Dublon, and Moen.

- 18 Section 3. All funds appropriated by this act shall be allotted,
- 19 managed, administered, and accounted for in accordance with applicable
- 20 law, including, but not limited to, the Financial Management Act of
- 21 1979. The allottee shall be responsible for ensuring that these funds,
- 22 or so much thereof as may be necessary, are used solely for the purpose
- 23 specified in this act, and that no obligations are incurred in excess
- 24 of the sum appropriated. The authority of the allottee to obligate
- 25 funds appropriated by this act shall lapse as of September 30, 1986.
