A BILL FOR AN ACT

To amend section 2 of Public Law No. 4-13 to authorize the President of the Federated States of Micronesia to establish an effective date for the Compact of Free Association subject to certain implementation conditions, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 2 of Public Law No. 4-13 is hereby amended to

2	completion of the U.S. Congressional review period specified
3	in section 101(f)(2) of U.S. Public Law 99-239 with respect
4	to such agreements, and submission of such agreements to the
5	Congress of the Federated States of Micronesia for ratification
6	pursuant to sections 2(b) and 4 of article IX of the Constitution
7	of the Federated States of Micronesia and to the State legislatures
8	for approval by at least three of the four State legislatures;
9	(3) Conclusion of the agreement provided for in section
10	111(c) of U.S. Public Law 99-239 and submission of such agreement
