A BILL FOR AN ACT

To further amend Public Law No. 4-11, as amended by Public Laws Nos. 4-12 and 4-21, by amending further section 2, as amended by Public Law No. 4-21, for the purpose of appropriating \$50,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, to provide supplemental funding for the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 2 of Public Law No. 4-11, as amended by Public Law No. 4-21, is hereby further amended to read as follows: "Section 2. Operating expenses of the legislative branch. 3 The sum of \$1,783,749 1,833,749, or so much thereof as may 4 be necessary, is hereby appropriated from the General Fund 5 of the Federated States of Micronesia for the fiscal year 6 ending September 30, 1986, for the operations of the 7 legislative branch of the National Government of the 8 Federated States of Micronesia during fiscal year 1986. 9 The sums appropriated by this section shall be apportioned 10 as follows: 11 General U.S. Grant 12 Special Fund Fund 13 (1) Office of the Speaker and Members 14 (a) Personnel expenses.... \$223,700 -0-15 -0-16 (c) Contractual services, 17 -0grants, subsidies, and contributions. 190,000 18 -0--0-(d) Others..... 19 (2) Staff offices 20 -0-571,608 (a) Personnel expenses.... 21 -0-(b) Travel..... 45,500 22 (c) Contractual services, 23 -0grants, subsidies, and contributions. 21,000
