

A BILL FOR AN ACT

To amend sections 2 and 3 of Public Law No. 4-92, Kosrae State public projects, to increase the funds provided to the Kosrae State Improvement Project Commission; to delete subsection (7); to decrease the funds appropriated for the congressional delegation office; to appropriate funds for Older Kosraean Community Groups; to renumber subsections (8), (9), (10), and (11); to change the allottee of statewide projects; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-92 is hereby amended
2 to read as follows:

3 "Section 2. The sum appropriated under section 1 of this
4 act shall be apportioned as follows:

17 Section 2. Section 3 of Public Law No. 4-92 is hereby amended to
 18 read as follows:

19 "Section 3. All funds appropriated by this act shall be
 20 allotted, managed, administered, and accounted for in accordance
 21 with applicable law, including, but not limited to, the
 22 Financial Management Act of 1979. The allottee shall be the
 23 chairman of the Kosrae State Improvement Project Commission for
 24 all the appropriations herein, except for appropriations
 25 under subsections (6), (7), (8), (9), (10), and (11) of

1 section 2. The allottee of funds appropriated under subsection
2 (87) of section 2 shall be the chairman of the board of KICA.
3 The allottee of funds appropriated under subsection (88) and
4 (11) of section 2 shall be the chairman of the Kosrae
5 congressional delegation. The allottee of funds appropriated
6 under subsections ~~(7)~~, ~~(8)~~ ~~and~~ ~~(11)~~ (6), (9), and (10) of
7 section 2 shall be the Governor of the State of Kosrae. The
8 allottees shall be responsible for ensuring that these funds, or
9 so much thereof as may be necessary, are used solely for the
10 purposes specified in this act, and that no obligations are
11 incurred in excess of the sum appropriated. The authority of
12 the allottees to obligate funds appropriated by this
13 act shall remain effective until all funds are fully expended."

14 Section 3. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its becoming
16 law without such approval.
