AN ACT

To appropriate the sum of \$600,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding public projects in the State of Yap, and for other purposes.

	BE IT ENACTED	BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1	. The sum of \$600,000, or so much thereof as may be
2	necessary, is	hereby appropriated from the General Fund of the
3	Federated Stat	es of Micronesia for the fiscal year ending September
4	30, 1987, for	the purpose of funding public projects in the State
5	of Yap.	
6	Section 2	. The sum appropriated under section 1 of this act
7	shall be appor	tioned as follows:

16	appropriated. The authority of the allottees to obligate funds		
17	appropriated by this act shall lapse as of September 30, 1988.		
18	Section 4. This act shall become law upon approval by the		
19	President of the Federated States of Micronesia or upon its becoming		
20	law without such approval.
