FOURTH REGULAR SESSION, 1986 CONGRESSIONAL BILL No. 4-369, C.D.1, C.D.2, C.D.3

AN ACT

To appropriate the sum of \$500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of funding public projects in the State of Kosrae, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:					
1	Section 1. The sum of \$500,000, or so much thereof as may be					
2	necessary, is hereby appropriated from the General Fund of the					
3	Federated States of Micronesia for the fiscal year ending September 30,					
4	1987, for the purpose of funding public projects in the State of					
5	Kosrae.					
6	Section 2. The sum appropriated under section 1 of this act					
7	shall be apportioned as follows:

18	Section 3. All funds appropriated by this act shall be allott	ed,
19	managed, administered, and accounted for in accordance with applica	ole
20	law, including, but not limited to, the Financial Management Act of	
21	1979. The allottee shall be the chairman of the Kosrae State Impro	ve-
22	ment Project Commission for all the appropriations herein, except f	or
23	appropriations under subsections (7), (8), (9), (10), and (11) of	
24	section 2. The allottee of funds appropriated under subsection (8)	
25	of section 2 shall be the chairman of the board of KICA. The allot	tee

1	of funds appropriated under subsection (9) of section 2 shall be the
2	chairman of the Kosrae congressional delegation. The allottee of funds
3	appropriated under subsections (7), (10) and (11) of section 2 shall
4	be the Governor of the State of Kosrae. The allottees shall be respon-
5	sible for ensuring that these funds, or so much thereof as may be
6	necessary, are used solely for the purposes specified in this act, and
7	that no obligations are incurred in excess of the sum appropriated.
8	The authority of the allottees to obligate funds appropriated by this
9	act shall remain effective until all funds are fully expended.
10	Section 4. This act shall become law upon approval by the
11	President of the Federated States of Micronesia or upon its becoming
12	law without such approval.
