## A RESOLUTION

Requesting the United Nations Trusteeship Council and the United Nations Security Council not to approve the termination of the Trusteeship Agreement which places the Trust Territory of the Pacific Islands under the care of the United States of America as the administering authority until the Compact of Free Association between the Governments of the United States of America and the Federated States of Micronesia becomes effective.

- 1 WHEREAS, one of the basic objectives of the Trusteeship System
- 2 as embodied under article 76(b) of the Trusteeship Agreement is
- 3 "to promote the political, economic, social, and educational advance-
- 4 ment of the inhabitants of the trust territories, and their progressive
- 5 development towards self-government or independence as may be appropriate
- 6 to the particular circumstances of each territory and its peoples and
- 7 the freely expressed wishes of the people concerned..."; and
- 8 WHEREAS, the people of the Federated States of Micronesia,
- 9 indirectly through their elected representatives and directly through
- 10 the plebiscite conducted throughout the Federated States of Micronesia,
- 11 have chosen the political status of Free Association with the United
- 12 States of America as the most desirable and viable political option
- 13 for the Federated States of Micronesia under the current circumstances;
- 14 and
- WHEREAS, the Compact of Free Association is now being butchered
- 16 in the United States Congress and may take a form different from
- 17 that which was approved by the people of the Federated States of
- 18 Micronesia in the duly conducted plebiscite; and
- 19 WHEREAS, any alteration in the Compact of Free Association
- 20 shall definitely make the Compact of Free Association different from
- 21 that which was adopted by the people of the Federated States of
- 22 Micronesia, and shall require further study by the people of the
- 23 Federated States of Micronesia; and
- 24 WHEREAS, to approve a political status different from the "freely
- 25 expressed wishes" of the people of the Federated States of Micronesia
