A RESOLUTION

Respectfully requesting the President of the Federated States of Micronesia and the Executive Director of the Commission on Future Political Status and Transition to report to the Congress their views on whether or not they believe the Commission should be abolished.

- 1 WHEREAS, in Presidential Communication No. 4-86, the Congress was
- 2 informed of an upcoming 2-day conference on the Compact of Free
- 3 Association; and
- WHEREAS, it would appear to be the responsibility of the Commission
- 5 on Future Political Status and Transition to organize and conduct this
- 6 conference; and
- WHEREAS, it is nevertheless the understanding of Congress that this
- 8 conference will be organized and conducted by the Federated States of
- 9 Micronesia Department of External Affairs; and
- WHEREAS, it would therefore appear that the Department of External
- 11 Affairs is assuming the functions of the Commission on Future Political
- 12 Status and Transition, thereby calling into question the need for sub-
- 13 stantial annual appropriations for the Commission; now, therefore,
- 14 BE IT RESOLVED by the Fourth Congress of the Federated States of
- 15 Micronesia, Second Regular Session, 1985, that the Congress hereby respect-
- l6 fully requests the President of the Federated States of Micronesia and the
- 17 Executive Director of the Commission on Future Political Status and
- 18 Transition to report to the Congress their views on whether or not they
- 19 believe the Commission should be abolished; and
- 20 BE IT FURTHER RESOLVED that certified copies of this resolution be
- 21 transmitted to the President of the Federated States of Micronesia, the
