A RESOLUTION

Respectfully requesting the nation friends of the Federated States of Micronesia to assist in funding the construction of the Capital facilities of the Federated States of Micronesia.

- 1 WHEREAS, article IX, section 2(1), of the Constitution of the
- 2 Federated States of Micronesia anticipates an area to be designated as the
- 3 capital of the Federated States of Micronesia; and
- WHEREAS, section 401 of title 1 of the Code of the Federated States
- 5 of Micronesia designated Pohnpei State as the permanent Capital of the
- 6 Federated States of Micronesia; and
- 7 WHEREAS, an understanding existed between the responsible Governments
- 8 that the United States Government will partially or wholly fund the con-
- 9 struction of the Capital facilities as set out under section 402 of title
- 10 1 of the Code of the Federated States of Micronesia; and
- 11 WHEREAS, pursuant to sections 403 through 408 of title 1 of the Code
- 12 of the Federated States of Micronesia, a coordinating committee has selected
- 13 Palikir Valley in the State of Pohnpei as the Capital site; and
- WHEREAS, pursuant to Public Law No. 2-66, a relatively substantial
- 15 sum of money has been appropriated and expended for architecture and
- 16 engineering work on the Capital facilities; and
- 17 WHEREAS, such architecture and engineering work has been completed
- 18 on the Capital facilities; and
- 19 WHEREAS, it does not appear likely that the Government of the United
- 20 States of America will make sufficient funds available for immediate con-
- 21 struction of the Capital facilities; now, therefore,
- 22 BE IT RESOLVED by the Fourth Congress of the Federated States of
- 23 Micronesia, Second Regular Session, 1985, that all nation friends of the
- 24 Federated States of Micronesia are hereby respectfully requested to assist
- 25 in the construction of the Capital facilities of the Federated States of

2	BE IT FURTHER RESOLVED that certified copies of this resolution be
3	transmitted to the President of the Federated States of Micronesia and
4	the Governments of all the nation friends of the Federated States of
5	Micronesia.
