- 12 WHEREAS, said agreement sets forth the responsibilities and
- 13 procedures under which the United States Department of Defense
- 14 shall provide military civic action construction teams to the
- 15 Federated States of Micronesia for local small-scale public works
- 16 projects; and
- 17 WHEREAS, performance under said agreement will benefit the
- 18 people of the Federated States of Micronesia; and
- 19 WHEREAS, said agreement is an international agreement
- 20 requiring ratification by Congress in accordance with article IX,
- 21 section 4, of the Constitution of the Federated States of Micro-
- 22 nesia; and
- WHEREAS, by a letter dated October 29, 1982, to the
- 24 Speaker of the Congress, the President of the Federated States of
- 25 Micronesia has recommended ratification of said agreement;
