A BILL FOR AN ACT

To further amend Public Law No. 4-11, as amended by Public Laws Nos. 4-12 and 4-21, by amending further sections 1, 5, and 7, as amended by Public Law No. 4-21, for the purpose of appropriating the sum of \$518,908 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1986, to provide supplemental funding for the Department of External Affairs, the Department of Social Services, the Office of the Attorney General, the Office of the Public Defender, the Office of the Budget, the Commission on Future Political Status and Transition, and Postal Services; to fund the Federated States of Micronesia Development Bank; to adjust employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 4-11, as amended by Public Law
2 No. 4-21, is hereby futher amended to read as follows:

3 "Section 1. Operating expenses of the executive branch. The sum
4 of \$6,380,578, or so much thereof as may be necessary, is hereby
5 appropriated from the United States Grant Special Fund and the
6 sum of \$268,295, or so much thereof as may be necessary, is
7 hereby appropriated from the General Fund of the Federated States
8 of Micronesia for the fiscal year ending September 30, 1986, for
9 the operations of the executive branch of the National Government
10 of the Federated States of Micronesia during fiscal year 1986.
11 The sums appropriated by this section shall be apportioned as
12 follows:



1 and to the agencies as provided in subsection (1) of this section,
2 except that the President may transfer up to 12 positions between the
3 departments and offices of the executive branch. This authorization
4 of positions covers all permanent employees, all contract personnel
5 whose employment extends for 1 year or more, and all positions funded
6 from United States federal programs. No funds may be expended for
7 unbudgeted positions."

8 Section 4. This act shall become law upon approval by the President of
9 the Federated States of Micronesia or upon its becoming law without such
10 approval.
