A BILL FOR AN ACT

To authorize the President of the Federated States of Micronesia to enter into an agreement with the University of Hawaii, obligating the Federated States of Micronesia to provide, for each fiscal year commencing 1986 through 1995, up to \$100,000 of indemnification to the University for medical malpractice claims arising from the conduct of employees and students of the proposed Medical Officer Training School; to authorize an appropriation therefor; and for other purposes.

BE ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Grant of authority. The President is hereby  
2 authorized to enter into an agreement with the University of Hawaii,  
3 obligating the Federated States of Micronesia to provide, for each  
4 fiscal year commencing 1986 through 1995, up to \$100,000 of  
5 indemnification to the University for medical malpractice claims  
6 arising from the conduct of employees and students of the proposed  
7 Medical Officer Training School. The agreement shall include such  
8 conditions for indemnification as the President deems are necessary to  
9 protect the interests of the Federated States of Micronesia.

10       Section 2. Authorization for an appropriation. The sum of  
11 \$100,000, or so much thereof as may be necessary, is hereby authorized  
12 to be appropriated from the General Fund of the Federated States of  
13 Micronesia for each fiscal year commencing 1986 through 1995, to  
14 provide, in accordance with the provisions of section 1 of this act,  
15 indemnification to the University of Hawaii for medical malpractice  
16 claims arising from the conduct of employees and students of the  
17 proposed Medical Officer Training School.

18       Section 3. Appropriations. All funds appropriated by this act  
19 shall be allotted, managed, administered, and accounted for in  
20 accordance with applicable law, including, but not limited to, the  
21 Financial Management Act of 1979. The allottee shall be the President  
22 of the Federated States of Micronesia. The allottee shall be  
23 responsible for ensuring that these funds, or so much thereof as may  
24 be necessary, are used solely for the purpose specified in this act,  
25 and that no obligations are incurred in excess of the sum appropriated.

1 The authority of the allottee to obligate funds appropriated by this  
2 act shall lapse as of the end of the fiscal year in which funds are  
3 appropriated.

4 Section 4. Effective date. This act shall become law upon  
5 approval by the President of the Federated States of Micronesia or  
6 upon its becoming law without such approval.
