A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended by Public Law No. 3-78, by amending section 117 for the purpose of changing the title of the exempt position of "National Planner" to "Director of the Office of Planning and Statistics," and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 117 of title 52 of the Code of the Federated
2 States of Micronesia is hereby amended to read as follows:

3 "Section 117. Application of chapter; Exemptions. The
4 National Public Service System shall apply to all employees
5 of and positions in the central Government of the Federated
6 States of Micronesia now existing or hereafter established
7 and to all personnel services performed for that Government
8 except the following, unless this chapter or provisions
9 thereof are specifically made applicable to them:

10 (1) members of the Congress of the Federated States
11 of Micronesia;

12 (2) the President and Vice President of the Federated
13 States of Micronesia;

14 (3) Justices and other Judges of the National Courts;

15 (4) the legislative counsel and the Clerk of the
16 Congress;

17 (5) the Public Auditor;

18 (6) the administrative officer of the National Courts;

19 (7) the special assistants and secretaries to the
20 President and Vice President;

21 (8) persons appointed by the President to fill the
22 following positions: Secretary of External Affairs,
23 Secretary of Finance, Secretary of Resources and
24 Development, Secretary of Social Services, Budget Officer,
25 Information Officer, Personnel Officer, *National Planner*

1 Director of the Office of Planning and Statistics, Attorney
2 General, and Public Defender, and their deputies, if any;

3 (9) persons appointed to any other positions by the
4 President with the advice and consent of the Congress;

5 (10) the Liaison Officer in Washington and all
6 ambassadors;

7 (11) persons or organizations retained by contract
8 when the Personnel Officer has certified that the service
9 to be performed is special or unique and nonpermanent and
10 is essential to the public interest, and that, because of
11 the degree of expertise or special knowledge required and
12 the nature of the services to be performed, it would not be
13 practical to obtain personnel to perform such services
14 through normal public service recruitment procedures;

15 (12) persons presently under contract of employment
16 not included in subsection (11) of this section, during the
17 life of such contract. No contract of employment shall be
18 entered into, renewed, or amended after the effective date
19 of this chapter, except in accordance with the provisions
20 of this chapter;

21 (13) temporary positions, required in the public
22 interest, for which the need does not exceed six months;

23 (14) positions requiring part-time or intermittent
24 work which does not exceed sixty hours in any calendar
25 month;

1 (15) positions filled by inmates, patients, and
2 students of institutions of the Federated States of
3 Micronesia;

4 (16) members of any board, public corporation,
5 commission, or similar body, in their capacity as such;

6 (17) officers, faculty, and employees of the Board of
7 Regents and the College of Micronesia; and

8 (18) positions specifically exempted by any other law
9 of the Federated States of Micronesia."


10 Section 2. This act shall become law upon approval by the
11 President of the Federated States of Micronesia or upon its becoming
12 law without such approval.
