A BILL FOR AN ACT

To further amend title 52 of the Code of the Federated States of Micronesia, as amended by Public Law No. 3-78, by adding new sections 167 and 168 for the purpose of establishing per diem rates for various locations, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Title 52 of the Code of the Federated States of Micro-
2 nesia is hereby further amended by the addition of a new section 167 to
3 read as follows:

4 "Section 167. Payment of travel expenses. Persons travelling
5 on Government business will be reimbursed for their hotel and
6 meal expenses by payment of per diem rates established
7 pursuant to section 2 of this act. Further compensation in
8 the form of an ambassadorial rate may be provided pursuant to
9 regulation.

10 (1) Payment of the per diem rates established by
11 subsections (1) and (2) of section 2 of this act will be paid
12 without provision of receipts.

13 (2) Payment of per diem rates in excess of those
14 set forth in subsection (1) of section 2 of this act but less
15 than the per diem rates set pursuant to subsection (3) of
16 section 2 of this act requires the presentation of receipts
17 for expenditures in excess of the rates in subsection (1) of
18 section 2 of this act and such payment shall be no greater
19 than the amount of the receipts presented."

20 Section 2. Title 52 of the Code of the Federated States of Micro-
21 nesia is hereby further amended by the addition of a new section 168
22 to read as follows:

23 "Section 168. Establishment of per diem rates. Per diem
24 rates are established as follows:

25 (1) The statutory rates for the specified locations

2 (a) Kosrae \$ 50.00/day

3 (b) Pohnpei..... 70.00/day

4 (c) Truk 70.00/day

5 (d) Yap 60.00/day

6 (e) Outer islands 15.00/day

7 (f) New York City 162.00/day

8 (g) Washington, D.C. 140.00/day

9 (h) San Francisco, CA 128.00/day

10 (i) Honolulu, Hawaii 95.00/day

11 (j) Guam 95.00/day;

12 (2) The per diem rates for all locations not specified

13 above shall be set by administrative directive of the

14 President; and

15 (3) Higher per diem rates for the locations specified

16 in subsection (1) of this section can be set by

17 administrative directive of the President, however such

18 higher rates can only be collected in accordance with the


19 provisions of subsection (2) of section 1 of this act."

20 Section 3. This act shall become law upon approval by the
21 President of the Federated States of Micronesia or upon its becoming
22 law without such approval.
