A BILL FOR AN ACT

To amend Public Law No. 4-51 by amending section 1 for the purpose of appropriating the sum of \$28,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the Department of Finance, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 4-51 is hereby amended to  
2 read as follows:

3 "Section 1. Operating expenses of the executive branch. The  
4 sum of ~~\$1,348,000~~ 1,374,098, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund of the  
6 Federated States of Micronesia and the sum of \$5,759,889, or so  
7 much thereof as may be necessary, is hereby appropriated from  
8 the United States Grant Special Fund for the fiscal year ending  
9 September 30, 1987, for the operations of the executive branch  
10 of the National Government of the Federated States of Micronesia  
11 during fiscal year 1987. The sums appropriated by this section  
12 shall be apportioned as follows:


