## A BILL FOR AN ACT

To appropriate the sum of \$104,900 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, for the purpose of defraying certain costs associated with providing security services for the National Government, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. The sum of \$104,900, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September 30,
4	1987, for the purpose of defraying certain costs associated with
5	providing security services for the National Government.
6	Section 2. The sum appropriated under section 1 of this act
7	shall be apportioned as follows:
8	(1) Temporary deputation of State police
9	officers to assist with security for the First Regular
10	Session of the Fifth Congress, the newly elected President
11	and Vice-President, and the inauguration ceremony for the
12	newly elected President and Vice-President\$36,600
13	(2) Overtime compensation for FSM Division of
14	Security and Investigation officers as required to provide
15	security for the First Regular Session of the Fifth
16	Congress, the newly elected President and Vice-President,
17	and the inauguration ceremony for the newly elected
18	President and Vice-President
19	(3) Eighteen additional FSM Division of Security
20	and Investigation officers and one investigator to provide
21	on-going security for the President and Vice-President,
22	Speaker of the Congress, and other Members of the Congress,
23	as needed 43,000
24	(4) One vehicle for FSM Division of
25	Security and Investigation

1	(5) Overtime compensation for FSM Division of
2	Security and Investigation officers as was required to
3	provide ballot box security in Pohnpei with respect to the
4	at-large FSM Senator election\$11,300
5	Section 3. All funds appropriated by this act shall be
6	allotted, managed, administered, and accounted for in accordance with
7	applicable law, including, but not limited to, the Financial
8	Management Act of 1979. The allottee shall be the President of the
9	Federated States of Micronesia who shall be responsible for ensuring
10	that these funds, or so much thereof as may be necessary, are used
11	solely for the purposes specified in this act, and that no
12	obligations are incurred in excess of the sum appropriated. The
13	authority of the allottee to obligate funds appropriated by this act
14	shall not lapse.
15	Section 4. This act shall become law upon approval by the
16	President of the Federated States of Micronesia or upon its becoming
17	law without such approval.
