A BILL FOR AN ACT

To further amend title 4 of the Code of the Federated States of Micronesia, as amended by Public Laws Nos. 3-3 and 3-40, by adding a new section 126 for the purpose of allowing the judiciary to administer in a judiciary bank account funds appropriated by Congress in the "Others" budget category, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Title 4 of the Code of the Federated States of
 Micronesia is hereby further amended by adding a new section 126
 to read as follows:
- 4 "Section 126. Judiciary Account.
 5 (1) Notwithstanding the pro

- (1) Notwithstanding the provisions of chapter 2, title 55 of the Code of the Federated States of Micronesia and regulations promulgated thereunder to the contrary, the Chief Justice of the Supreme Court or his designee may, from time to time, request that the Secretary of Finance transfer funds appropriated in the judiciary budget for 'Others' into a separate judiciary bank account. The Secretary of Finance shall promptly deposit the funds as requested; PROVIDED that the total balance in the judiciary account shall at no time exceed \$30,000.
 - expended only upon the signature of the Chief Justice or, in his absence, his authorized designee. The judiciary account shall be used only for payments and procurement of supplies and materials authorized under the 'Others' category of the judiciary budget, subject to the discretion and authority of the Chief Justice or his designee to solely administer, manage, and control all funds deposited in the judiciary account.
 - (3) The Chief Justice or his designee shall keep a
