A BILL FOR AN ACT

To amend title 40 of the Code of the Federated States of Micronesia by amending sections 121, 123, 124, 125, 127 and 128 to change the composition of the Board of Education to reflect the changes made by Public Law No. 5-21, to give the Board of Education greater power and responsibilities, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 121 of title 40 of the Code of the Federated States of Micronesia is hereby amended to read as follows: "Section 121. Definitions. As used herein, unless 3 otherwise indicated by the context: 'Board' means the Federated States of Micronesia Board 5 of Education. '¢h1éf Assistant Secretary of ∉Education' means the thirt Assistant Secretary of the division 8 of dEducation within of the Department of \$66141 \$6741665 Human Resources of the Federated States of Micronesia. 10 (3) 'President' means the President of the Federated 11 12 States of Micronesia. (4) 'Secretary of \$66141 \$6741668 Human Resources' means 13 the Secretary of the Department of \$66141 \$6741668 Human 14 Resources of the Federated States of Micronesia." 15 Section 2. Section 123 of title 40 of the Code of the 16 Federated States of Micronesia is hereby amended to read as follows: 17 "Section 123. There shall be one member 21 from each State of the Federated States of Micronesia. 18	Section 6. Section 128 of title 40 of the Code of the Federated
19	States of Micronesia is hereby amended to read as follows:

22	Sétvicés Human Resources, upon approval of the President, is
23	hereby authorized to issue and promulgate rules and regulations
24	implementing the provisions of this subchapter, which rules and
25	regulations shall have the force and effect of law."
