A BILL FOR AN ACT

To further amend Public Law No. 5-15, as amended by Public Laws Nos. 5-28 and 5-45, by further amending sections 1, 5, and 11, as amended by Public Law No. 5-28, for the purpose of appropriating the sum of \$396,414 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, as supplemental funding for the National budget, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 5-15, as amended by Public
2 Law No. 5-28, is hereby further amended to read as follows:

3 "Section 1. Operating expenses of the executive branch.

4 The sum of \$8,136,731 8,474,965, or so much thereof as may be
5 necessary, is hereby appropriated from the General Fund of the
6 Federated States of Micronesia for the fiscal year ending
7 September 30, 1988, for the operations of the executive branch
8 of the National Government of the Federated States of Micronesia
9 during fiscal year 1988. The sum appropriated by this section
10 shall be apportioned as follows:

2 Law No. 5-28, is hereby further amended to read as follows:

3 "Section 5. Operating expenses of agencies of the National
4 Government. The sum of \$1,388,499 1,400,299, or so much thereof
5 as may be necessary, is hereby appropriated from the General
6 Fund of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1988, for the operations of independent
8 agencies, commissions, authorities, boards, bureaus, and other
9 organizations of the National Government of the Federated States
10 of Micronesia during fiscal year 1988. The sum appropriated by
11 this section shall be apportioned as follows:

12 (1) Commission on Future Political Status and Transition
13 (a) Personnel expenses.....\$ 18,000
14 (b) Travel..... 17,000
15 (c) Contractual services,
16 grants, subsidies, and contributions..... 55,000
17 (d) Others..... 8,000
