FIFTH CONGRESS OF THE FEDERATED STATES OF MICRONESIA

FIRST SPECIAL SESSION, 1987

CONGRESSIONAL BILL No. 5-98, C.D.1, C.D.2

AN ACT

To further amend Public Law No. 4-51, as amended by Public Laws Nos. 4-88 and 5-1, by further amending sections 1 and 5, as amended by Public Law No. 4-88, for the purpose of appropriating the sum of \$115,757 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the operations of the Office of the President, the Department of External Affairs, the Department of Resources and Development, and the Foreign Investment Board, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1       Section 1. Section 1 of Public Law No. 4-51, as amended by
- 2       Public Law No. 4-88, is hereby further amended to read as follows:

- 4       The sum of \$7,358,625, or so much thereof as may be
- 5       necessary, is hereby appropriated from the General Fund
- 6       of the Federated States of Micronesia for the fiscal year
- 7       ending September 30, 1987, for the operations of the
- 8       executive branch of the National Government of the
- 9       Federated States of Micronesia during fiscal year 1987.
