CONGRESSIONAL BILL NO. 5-398, C.D.1

AN ACT

To appropriate the sum of \$37,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding certain urgent medical referral program needs, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$37,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 1989, for the purpose of funding certain urgent medical referral
5	program needs. Of the funds appropriated by this act, \$25,000 shall
6	be deemed to have come from funds available under section 216(a)(2)
7	of the Compact of Free Association, and \$12,000 shall be deemed to
8	have come from funds available under section 221(b) of the Compact of
9	Free Association.
10	Section 2. The sum appropriated by section 1 of this act shall
11	be apportioned as follows:
12	(1) The payment of overdue or outstanding obligations to
13	the Pohnpei Hospital Hemodialysis Center of referral patients from
14	the States of Kosrae and Truk (which shall be deemed to have come
15	from funds appropriated from those available under section 216(a)
16	(2) of the Compact of Free Association)\$ 25,000
17	(2) Van for the Honolulu medical referral operations
18	(which shall be deemed to have come from funds appropriated from
19	those available under section 221(b) of the Compact of Free
20	Association)
21	Section 3. All funds appropriated by this act shall be allotted

1	applicable law, including, but not limited to, the Financial Manage-
2	ment Act of 1979. The allottee for the funds appropriated under
3	subsection (1) of section 2 of this act shall be the Governor of
4	the State of Pohnpei, and the allottee for the funds appropriated
5	under subsection (2) of section 2 of this act shall be the Secretary
6	of the Department of Human Resources of the Federated States of
7	Micronesia. Each allottee shall be responsible for ensuring
8	that these funds, or so much thereof as may be necessary, are used
9	solely for the purposes specified in this act, and that no obligations
10	are incurred in excess of the sum appropriated. The authority of the
11	allottees to obligate funds appropriated by this act shall lapse as
12	of September 30, 1989.
13	Section 4. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
