A BILL FOR AN ACT

To appropriate the sum of \$791,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, for the purpose of funding Southern Namoneas public projects in the Southern Namoneas, State of Truk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$791,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the Federated  
3 States of Micronesia for the fiscal year ending September 30, 1988, for  
4 the purpose of funding Southern Namoneas public projects in the Southern  
5 Namoneas, State of Truk.

6 Section 2. The sum appropriated under section 1 of this act shall  
7 be apportioned as follows:

- 8 (1) Tonowas public projects:
  - 9 (a) Fisheries projects ..... \$100,000
  - 10 (b) Agricultural projects ..... 50,000
  - 11 (c) Youth programs and needs ..... 20,000
  - 12 (d) Meeting halls ..... 50,000
  - 13 (e) Women's Association needs ..... 20,000
- 14 (2) Uman/Fonuweisom public projects:
  - 15 (a) Fisheries projects ..... 80,000
  - 16 (b) Agricultural projects ..... 60,000
  - 17 (c) Youth programs and needs ..... 20,000
  - 18 (d) Meeting halls ..... 30,000
  - 19 (e) Women's Association needs ..... 20,000
- 20 (3) Fefan public projects:
  - 21 (a) Fisheries projects ..... 80,000
  - 22 (b) Agricultural projects ..... 100,000
  - 23 (c) Youth programs and needs ..... 20,000
  - 24 (d) Meeting halls ..... 30,000
  - 25 (e) Women's Association needs ..... 20,000

- 1                   (4) Tsis public projects:
- 2                    (a) Fisheries projects ..... \$ 20,000
- 3                    (b) Agricultural projects ..... 10,000
- 4                    (c) Youth programs and needs ..... 10,000
- 5                    (d) Meeting halls ..... 8,000
- 6                    (e) Women's Association needs ..... 5,000
- 7                   (5) Parem public projects:
- 8                    (a) Fisheries projects ..... 10,000
- 9                    (b) Agricultural projects ..... 10,000
- 10                   (c) Youth programs and needs ..... 5,000
- 11                   (d) Meeting halls ..... 8,000
- 12                   (e) Women's Association needs ..... 5,000

13           Section 3. All funds appropriated by this act shall be allotted,  
 14 managed, administered, and accounted for in accordance with applicable  
 15 law, including, but not limited to, the Financial Management Act of  
 16 1979. The allottee shall be the Governor of the State of Truk  
 17 who shall be responsible for ensuring that these funds, or so much  
 18 thereof as may be necessary, are used solely for the purpose specified  
 19 in this act, and that no obligations are incurred in excess of the sum  
 20 appropriated. The authority of the allottee to obligate funds appro-  
 21 priated by this act shall lapse as of September 30, 1988.
