A BILL FOR AN ACT

To further amend section 2 of Public Law No. 4-51, as amended by Public Laws Nos. 4-88 and 5-1, to appropriate the sum of \$15,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the Congress of the Federated States of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 4-51, as amended by
2 Public Laws Nos. 4-88 and 5-1, is hereby further amended to read as
3 follows:

4 "Section 2. Operating expenses of the legislative branch.

5 The sum of ~~\$1,877,683~~ 1,892,683, or so much thereof as may be
6 necessary, is hereby appropriated from the General Fund of the
7 Federated States of Micronesia for the fiscal year ending
8 September 30, 1987, for the operations of the legislative branch
9 of the National Government of the Federated States of Micronesia
10 during fiscal year 1987. The sum appropriated by this section
11 shall be apportioned as follows:

 - 13 (a) Personnel expenses \$297,200
 - 14 (b) Travel ~~376,400~~ 391,400
 - 15 (c) Contractual services,
