A BILL FOR AN ACT

To further amend Public Law No. 4-51, as amended by Public Laws Nos. 4-88 and 5-1, by further amending section 1, as amended by Public Law No. 4-88, for the purpose of appropriating the sum of \$193,523 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1987, as supplemental funding for the operations of the Office of the President and the Department of External Affairs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 4-51, as amended by
2 Public Law No. 4-88, is hereby further amended to read as follows:

3 "Section 1. Operating expenses of the executive branch.
4 The sum of ~~\$7,247,468~~ 7,440,991, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1987, for the operations of the
8 executive branch of the National Government of the
9 Federated States of Micronesia during fiscal year 1987.

10 The sum appropriated by this section shall be apportioned
11 as follows:
