A BILL FOR AN ACT

To amend Public Law No. 5-59 by adding a new section 2 for the purpose of specifying the projects for which funds originally appropriated for public projects in Yap State are to be used, amending section 2 and renumbering section 3, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Public Law No. 5-59 is hereby amended by adding a  
2 new section 2 to read as follows:

3 "Section 2. The sum appropriated under section 1 of this  
4 act shall be apportioned as follows:

- 7 (2) Hospital warehouse..... 50,000
- 8 (3) YWA-Day care center..... 10,000

- 12 (7) Dalipebinaw Elementary School..... 48,000
- 13 (8) Road development and maintenance

- 17 (10) Tagailap Elementary School..... 35,000
- 18 (11) Asor Elementary School..... 35,000
- 19 (12) Sorol Elementary School..... 35,000
- 20 (13) Outer Island transportation
- 21 equipment..... 51,000
- 22 (14) Falalus Island project..... 10,000
- 23 (15) Leebnaw Women's project..... 10,000
- 24 (16) Gilman municipal project..... 15,000
- 25 (17) Maq Youth projects..... 10,000

7 Section 2. Section 2 of Public Law No. 5-59 is hereby amended  
8 to read as follows:

9 "Section 23. All funds appropriated by this act shall be  
10 allotted, managed, administered, and accounted for in  
11 accordance with applicable law, including, but not limited  
12 to, the Financial Management Act of 1979. The allottee  
13 shall be the Governor of Yap State who shall be responsible  
14 for ensuring that these funds, or so much thereof as may  
15 be necessary, are used solely for the purpose specified in  
16 this act, and that no obligations are incurred in excess of  
17 the sum appropriated. The authority of the allottee to  
18 obligate funds appropriated by this act shall ~~be effective~~  
19 ~~as of January 1, 1989 and shall~~ lapse as of September 30,  
20 ~~1989~~ 1990."

21 Section 3. Section 3 of Public Law No. 5-59 is hereby renumbered  
22 as section 4.




