

AN ACT

To appropriate the sum of \$117,353 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1988, for the purpose of completing certain public projects and programs in the State of Pohnpei, which projects and programs were not completed because funding lapsed, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$117,353, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September 30,
4 1988, for the purpose of completing certain public projects and
5 programs in the State of Pohnpei, which projects and programs were not
6 completed because funding lapsed.

7 Section 2. The sum appropriated under section 1 of this act shall
8 be apportioned as follows:

- 9 (1) Kitti public projects:
 - 10 (a) Kitti Economic Development Loan Fund.. \$17,500.00
 - 11 (b) Lakemwei farm road..... 3,000.00
 - 12 (c) Enipein farm road..... 2,500.00
 - 13 (d) Pohnalamwahu road/coral..... 1,000.00
 - 14 (e) Tukunisou road/coral..... 2,000.00
 - 15 (f) Other public projects..... 1,049.51
- 16 (2) Madolenihmw public projects:
 - 17 (a) Pasoile causeway and bridge..... 7,743.36
 - 18 (b) Economic Development Loan Fund..... 5,000.00
 - 19 (c) Other public projects..... 1,586.48
- 20 (3) Kolonia, Sokehs, Sapwuahfik, Nukuoro and
 - 21 Kapingamarangi public projects: 75,973.65

22 Section 3. All funds appropriated by this act shall be allotted,



1 managed, administered, and accounted for in accordance with applicable
2 law, including, but not limited to, the Financial Management Act of
3 1979. The allottee for funds appropriated under subsection (1) of
4 section 2 of this act shall be the Luhken Menlap of Kitti municipal
5 government. The allottee for funds appropriated under subsection (2)
6 of section 2 of this act shall be the Menin Keder Lapalap of
7 Madolenihmw municipal government. The allottee for funds appropriated
8 under subsection (3) of section 2 of this act shall be the Pohnpei
9 Community Action Agency. The allottees shall be responsible for
10 ensuring that these funds, or so much thereof as may be necessary, are
11 used solely for the purpose specified in this act, and that no
12 obligations are incurred in excess of the sum appropriated. The
13 authority of the allottees to obligate funds appropriated by this act
14 shall lapse as of September 30, 1988.

15 Section 4. This act shall become law upon approval by the
16 President of the Federated States of Micronesia or upon its becoming
17 law without such approval.
