A BILL FOR AN ACT

To appropriate the sum of \$150,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of paying legal expenses in Truk State, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$150,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 1990, for the purpose of paying legal expenses in Truk State.
5	Section 2. The sum appropriated under section 1 of this act
6	shall be apportioned as follows:
7	(1) Reimbursement of Truk State expenses for law
8	enforcement activities involving National crimes \$ 75,000
9	(2) Payment of expenses relating to
10	legal proceedings
11	Section 3. All funds appropriated by this act shall be
12	allotted, managed, administered, and accounted for in accordance with
13	applicable law, including, but not limited to, the Financial
14	Management Act of 1979; PROVIDED, however, that the allottee of
15	the funds appropriated under subsection (1) of section 2 of this act
16	shall be the Governor of Truk State and that those funds shall not be
17	disbursed from the General Fund to the allottee unless the President
18	certifies that Truk State has entered into a joint law enforcement
19	agreement for the period of October 1, 1989 to September 30, 1990
20	with the National Government pursuant to chapter 12 of title 12 of
21	the Code of the Federated States of Micronesia; and PROVIDED FURTHER,
22	that the allottee of the funds appropriated under subsection (2) of
23	section 2 of this act shall be the President and that those funds
24	shall not be disbursed from the General Fund unless the President
25	certifies that he has been presented with appropriate statements of

1	fees and expenses. The allottees shall be responsible for ensuring
2	that these funds, or so much thereof as may be necessary, are used
3	solely for the purposes specified in this act, and that no
4	obligations are incurred in excess of the sum appropriated. The
5	authority of the allottees to obligate funds appropriated by this act
6	shall lapse as of September 30, 1990.
7	Section 4. This act shall become law upon approval by the
8	President of the Federated States of Micronesia or upon its becoming
9	law without such approval.
