C. B. No. 4-220

A BILL FOR AN ACT

To appropriate the sum of \$400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding public projects in the Mortlocks Islands of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. The sum of \$93,000, or so much thereof as may be  
2 necessary, is hereby appropriated from the General Fund of the  
3 Federated States of Micronesia for the fiscal year ending September  
4 30, 1990, for the purpose of funding public projects in the Upper  
5 Mortlocks area of the Mortlocks Islands of Chuuk State. The sum  
6 appropriated by this section shall be apportioned as follows:

3 Federated States of Micronesia for the fiscal year ending September  
4 30, 1990, for the purpose of funding public projects in the

8         Section 5. All funds appropriated by this act shall be  
9 allotted, managed, administered, and accounted for in accordance with  
10 applicable law, including, but not limited to, the Financial  
11 Management Act of 1979. The allottee of the funds appropriated by  
12 section 1 of this act shall be the Upper Mortlocks Authority; the  
13 allottee of the funds appropriated by section 2 of this act shall be  
14 the Mid-Mortlocks Authority; and the allottee of the funds  
15 appropriated by sections 3 and 4 of this act shall be the Lower  
16 Mortlocks Authority. The allottees shall be responsible for ensuring  
17 that these funds, or so much thereof as may be necessary, are used  
18 solely for the purposes specified in this act, and that no  
19 obligations are incurred in excess of the sum appropriated. The  
20 authority of the allottees to obligate funds appropriated by this act  
21 shall not lapse until expended.
