A BILL FOR AN ACT

To appropriate the sum of \$1,800,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of funding statewide and other public projects in Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 3. Community Action Agency Block Grant for Nett, U, 14
- Pingelap and Mokil public projects. The sum of \$350,000, or so much 15
- thereof as may be necessary, is hereby appropriated from the General 16
- Fund of the Federated States of Micronesia for the fiscal year ending 17
- September 30, 1990, for the purpose of funding a Community Action 18
- Agency Block Grant for projects and incentive program grants in Nett, 19
- U, Pingelap and Mokil, Pohnpei State. 20
- Section 4. Statewide public projects. The sum of \$500,000, or 21
- 22 so much thereof as may be necessary, is hereby appropriated from the
- General Fund of the Federated States of Micronesia for the fiscal 23
