A BILL FOR AN ACT

To further amend Public Law No. 6-49, as amended by Public Laws Nos. 6-55 and 6-96, by further amending section 6, as amended by Public Law No. 6-55, to reallocate for typhoon relief needs certain funds appropriated therein for public projects in the Pattiw, Weito, and Hall Islands of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 6-49, as amended by Public
2 Law No. 6-55, is hereby further amended to read as follows:

3 "Section 6. Pattiw, Weito, and Hall Islands public
4 projects. The sum of \$240,000, or so much thereof as may
5 be necessary, is hereby appropriated from the General Fund
6 of the Federated States of Micronesia for the fiscal year
7 ending September 30, 1990, for the purpose of funding
8 certain public projects in the Pattiw, Weito, and Hall
9 Islands, Chuuk State. The sum appropriated by this section
10 shall be apportioned as follows:
