Public Law No. 6 - 10 1

AN ACT

To amend sections 1, 3, 4 and 5 of Public Law No. 6-74 for the purpose of modifying the use of certain previously appropriated funds for public projects in Pohnpei State, designating the allottees of new public projects, appropriating the sum of \$30,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991 for new projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 1 of Public Law No. 6-74 is hereby amended
2	to read as follows:
3	"Section 1. Sokehs, Kolonia, Sapwuahfik, Nukuoro, and
4	Kapingamarangi public projects. The sum of \$525,000, or so
5	much thereof as may be necessary, is hereby appropriated
6	from the General Fund of the Federated States of Micronesia
7	for the fiscal year ending September 30, 1990, for the
8	purpose of funding certain public projects in Sokehs,
9	Kolonia, Sapwuahfik, Nukuoro, and Kapingamarangi, Pohnpei
10	State. The sum appropriated under this section shall be
11	apportioned as follows:

14	(b) Sokehs civil engineer, housing and

7	Section 3. Section 4 of Public Law No. 6-74 is hereby amended
8	to read as follows:
9	"Section 4. Statewide public projects. The sum of \$525,000,
10	or so much thereof as may be necessary, is hereby appro-
11	priated from the General Fund of the Federated States of
12	Micronesia for the fiscal year ending September 30, 1990,
13	for the purpose of funding certain statewide public projects
14	in Pohnpei State. The sum appropriated by this section
15	shall be apportioned as follows:

13	to read as follows:
14	"Section 5. Allotment and management of funds and lapse
15	date. All funds appropriated by this act shall be
16	allotted, managed, administered, and accounted for in
17	accordance with applicable law, including, but not limited
18	to, the Financial Management Act of 1979. The allottee of
19	the funds appropriated under paragraphs (a), (b), (c) and
20	(d) of subsection (1) of section 1 of this act shall be the
21	Chief Magistrate of the Sokehs Municipal Government. The
22	allottee of the funds appropriated under subsection (2) of
23	section 1 of this act shall be the Kolonia Town Mayor. The
24	allottee of the funds appropriated under subsection (3) of
25	section 1 of this act shall be the Luhkenkolwof of

Sapwuahfik. The allottee of the funds appropriated under subsection (4) of section 1 of this act shall be the Chief Magistrate of the Nukuoro Municipal Government. The allottee of the funds appropriated under subsection (5) of section 1 of this act shall be the Chief Magistrate of the Kapingamarangi Municipal Government. The allottee of the funds appropriated under subsections (1) and (2) of section 2 and paragraph (3)(a) of section 2 of this act shall be the Menin Keder Lapalap of the Madolenihmw Municipal Government. The allottee of the funds appropriated under paragraph (3)(b) of section 2 shall be the Madolenihmw Municipal Government. The allottee of the funds appropriated under subsections (4) and (5) of section 2 and paragraph (6)(a) of section 2 shall be the Luhkenmenlap of the Kitti Municipal Government. The allottee of the funds appropriated under paragraph (6)(b) of section 2 shall be the Kitti Municipal Government. The allottees of the funds appropriated under subsections (1), (2), (4) and (5) of section 2 of this act and paragraphs (3)(a) and (6)(a) of section 2 of this act shall submit detailed funds status and project status reports to the Congress of the Federated States of Micronesia at the beginning of each quarter of each fiscal year. The allottee of the funds appropriated under paragraphs (e), (f), (g) and (h) of subsection (1) of section 1; subsections (6) and (7) of section 1; section

1	3(1); and subsection (8) of section 4 of this act shall be
2	the Pohnpei Community Action Agency; PROVIDED, however, that
3	the funds appropriated under subsection (6) of section 1 of
4	this act shall not be allotted before October 1, 1990. The
5	allottee of the funds appropriated under subsection (2) of
6	section 3 shall be the Coconut Development Authority. The
7	allottees shall be responsible for ensuring that these
8	funds, or so much thereof as may be necessary, are used
9	solely for the purposes specified in this act, and that no
10	obligations are incurred in excess of the sum appropriated.
11	The authority of the allottees to obligate funds appropriated
12	by this act shall not lapse until expended."
13	Section 5. This act shall become law upon approval by the
14	President of the Federated States of Micronesia or upon its becoming
15	law without such approval.
