CONGRESSIONAL BILL NO. 6-322, C.D.1, C.D.2

Public Law No. 6 - 104

AN ACT

To amend Public Law No. 6-24 by amending section 8 to provide that the Convention shall propose amendments to the Constitution to be placed on a ballot for a referendum to be held during the special election for the at-large Member of the Seventh Congress who will take the seat vacated by the Member of Congress elected as President, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- Section 1. Section 8 of Public Law No. 6-24 is hereby amended 2 to read as follows:
- 3 "Section 8. Duties of the Convention.
 - (1) The Convention shall propose amendments to the Constitution to be placed on a ballot for a referendum to be held during the special election for the at-large Member of the Seventh Congress who will take the seat vacated by the Member of Congress elected as President.
 - (2) Proposed amendments to the Constitution shall be in the format set forth in the Constitutional Amendment Procedure Act, title 1, section 703 of the Code of the Federated States of Micronesia and any regulations pursuant thereto.
 - (3) When said amendments have been proposed by the Convention, the Convention shall notify the President of the Federated States of Micronesia who shall transmit a copy of the amendments to the Congress of the Federated States of Micronesia, and shall conduct a referendum as provided by title 1, chapter 7 of the Code of the Federated States of Micronesia; provided, however, that notwithstanding any inconsistent provisions of section 703(1) of title 1 of the Code of the Federated States of Micronesia, the voting for
