AN ACT

To appropriate the sum of \$900,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, and to authorize the appropriation of \$1,500,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, for the purpose of constructing airports in the outer islands of Pohnpei, Truk, and Yap States, and for purchase and operation of aircrafts for outer islands, and for other purposes.

	BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
1	Section 1. The sum of \$900,000, or so much thereof as may be
2	necessary, is hereby appropriated from the General Fund of the
3	Federated States of Micronesia for the fiscal year ending September
4	30, 1990, for the purpose of constructing airports in, and for the
5	purchase and operation of aircrafts for, the outer islands of Yap
6	State.
7	Section 2. The sum appropriated under section 1 of this act
8	shall be apportioned as follows:
9	(1) Yap State
10	(a) Ulithi \$ 300,000
11	(b) Fais 300,000
12	(c) Woleai 300,000
13	Section 3. The sum of \$1,500,000 is hereby authorized to be
14	appropriated from the General Fund of the Federated States of Micro-
15	nesia for the fiscal year ending September 30, 1990, for the purpose
16	of constructing airports in, and for the purchase and operation of
17	aircrafts for, the outer islands of Pohnpei and Truk States. The sum
18	authorized to be appropriated under this section shall be apportioned
19	as follows:
20	(1) Pohnpei State
21	(a) Nukuoro \$300,000

(b) Sapwuafik

5	Section 4. All funds appropriated by this act shall be allotted,
6	managed, administered, and accounted for in accordance with applicable
7	law, including, but not limited to, the Financial Management Act
8	of 1979. The allottee shall be responsible for ensuring that these
9	funds, or so much thereof as may be necessary, are used solely for
10	the purpose specified in this act, and that no obligations are
11	incurred in excess of the sum appropriated. The authority of the
12	allottee to obligate funds appropriated by this act shall lapse as
13	of September 30, 1990.
14	Section 5. This act shall become law upon approval by the
15	President of the Federated States of Micronesia or upon its becoming
16	law without such approval.
