A BILL FOR AN ACT

To further amend Public Law No. 5-52, as amended, by further amending section 1, as amended by Public Laws Nos. 5-83, 5-106, 5-127 and 6-4, for the purpose of reallocating funds appropriated for the Office of Administrative Services, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 5-52, as amended by Public  
2 Laws Nos. 5-83, 5-106, 5-127 and 6-4, is hereby further amended to read  
3 as follows:

4 "Section 1. Operating expenses of the executive branch.

5 The sum of \$9,186,147, or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund  
7 of the Federated States of Micronesia for the fiscal year  
8 ending September 30, 1989, for the operations of the  
9 executive branch of the National Government of the Federated  
10 States of Micronesia during fiscal year 1989. The sum  
11 appropriated by this section shall be apportioned as follows:
