A BILL FOR AN ACT

To amend Public Law No. 6-10 by amending sections 2 and 14 for the purpose of appropriating the sum of \$294,746 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the legislative branch; to modify employment ceilings; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 6-10 is hereby amended  
2 to read as follows:

3 "Section 2. Operating expenses of the legislative branch.

4 The sum of ~~\$2,138,200~~ 2,452,946, or so much thereof as may  
5 be necessary, is hereby appropriated from the General Fund  
6 of the Federated States of Micronesia for the fiscal year  
7 ending September 30, 1990, for the operations of the  
8 legislative branch of the National Government of the  
9 Federated States of Micronesia during fiscal year 1990.

10 The sum appropriated by this section shall be apportioned  
11 as follows:

12 (1) Office of the Speaker and Members

- 13 (a) Personnel expenses..... \$ 400,100
- 14 (b) Travel..... 381,400
- 15 (c) Contractual services,
- 16 grants, subsidies, and contributions..... 136,800
- 17 (d) Others..... -0-

- 19 (a) Personnel expenses..... ~~712,000~~ 734,779
- 20 (b) Travel..... 175,500
- 21 (c) Contractual services,
- 22 grants, subsidies, and contributions..... ~~49,800~~ 218,145
- 23 (d) Others..... ~~176,000~~ 280,222

24 (3) Kosrae Delegation Office..... 13,000

25 (4) Pohnpei Delegation Office..... 24,000

 8 branches and agencies of the National Government.

17 individually to each of the departments and offices of the  
18 executive and legislative branches, the National judiciary,  
19 the Public Auditor, and to the agencies as provided in  
20 subsection (1) of this section, except that the President  
21 may transfer up to 12 positions between the departments  
22 and offices of the executive branch. This authorization  
23 of positions covers all permanent employees and all  
24 contract personnel whose employment extends for more than  
25 90 days. No funds may be expended for unbudgeted positions."
