A BILL FOR AN ACT

To amend Public Law No. 6-10 by amending section 12 for the purpose of appropriating the sum of \$107,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, to provide funding for joint law enforcement for Truk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 12 of Public Law No. 6-10 is hereby amended
2 to read as follows:

3 "Section 12. Other National Government programs, grants,
4 subsidies, contributions, and refunds. The sum of
5 ~~\$1,145,000~~ 1,252,009, or so much thereof as may be
6 necessary, is hereby appropriated from the General Fund of
7 the Federated States of Micronesia for the fiscal year
8 ending September 30, 1990, for special programs, grants,
9 subsidies, contributions, and refunds of the National
10 Government of the Federated States of Micronesia during
11 fiscal year 1990. The sum appropriated by this section
12 shall be apportioned as follows:


