A BILL FOR AN ACT

To further amend Public Law No. 5-89, as amended, by further amending section 6, as amended by Public Laws Nos. 5-99, 5-126 and 6-47, to change the use of certain funds for Chuuk public projects, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA: Section 1. Section 6 of Public Law No. 5-89, as amended by Public Laws Nos. 5-99, 5-126 and 6-47, is hereby further amended to read as 3 follows: "Section 6. Halls, Western Islands and Namonwitto public 4 projects. The sum of \$200,000, or so much thereof as may be necessary, is hereby appropriated from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1989, for the purpose of funding 8 certain public projects in the Halls, Western Islands and 9 Namonwitto, Truk State.
