A BILL FOR AN ACT

To appropriate the sum of \$25,297 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1991, for the purpose of reappropriating certain lapsed funds for Madolenihmw and Kitti public projects and programs, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$17,070, or so much thereof as may be
2 necessary, is hereby appropriated from the General Fund of the
3 Federated States of Micronesia for the fiscal year ending September
4 30, 1991, for the purpose of funding Madolenihmw public projects and
5 programs. The funds appropriated under this section shall be
6 apportioned as follows:

- 7 (1) Ohpis en Sounkopwung..... \$3,000
- 8 (2) Elementary school aid..... 165
- 9 (3) Mesihsou and Ohwa water extension..... 240
- 10 (4) Pahlap river bridge..... 3,000
- 11 (5) Architectural and engineering design for a
12 municipal office and construction thereof, and/or municipal
13 operations..... 6,700
- 14 (6) Mahnd road and coral..... 2,000
- 15 (7) Radio equipment, transportation and municipal
16 operations..... 1,510
- 17 (8) Other Madolenihmw public projects and programs.. 455

18 Section 2. The sum of \$8,227, or so much thereof as may be
19 necessary, is hereby appropriated from the General Fund of the Federated
20 States of Micronesia for the fiscal year ending September 30, 1991,
21 for the purpose of funding Kitti public projects and programs. The
22 funds appropriated under this section shall be apportioned as follows:

- 23 (1) Wone water system..... \$ 142
- 24 (2) Rohnkitti to Pwok water system..... 162
- 25 (3) Nanmahnd Youth Organization..... 372

1	(4) Mwudok Youth Organization.....	\$ 532
2	(5) Office of Kaunen Wehi operations and vehicle	
3	repair.....	2,308
4	(6) Office of Pwihnen Wahu operations and vehicle...	2,800
5	(7) Radio equipment, transportation equipment

7	(8) Section I fishermen's channel clearings.....	790

9 Section 3. All funds appropriated by this act shall be
10 allotted, managed, administered, and accounted for in accordance with
11 applicable law, including, but not limited to, the Financial
12 Management Act of 1979. The allottee of the funds appropriated under
13 section 1 of this act shall be the Menin Keder Lapalap of the
14 Madolenihmw Municipal Government, except for those funds appropriated
15 under subsection (7) of section 1 of this act for which the allottee
16 shall be the Menin Keder Lapalap of the Madolenihmw Municipal
17 Government and the Menin Tiensapw of Madolenihmw. The allottee of
18 the funds appropriated under section 2 of this act shall be the
19 Luhken Menlap of the Kitti Municipal Government, except for those
20 funds appropriated under subsection (7) of section 2 of this act for
21 which the allottee shall be the Luhken Menlap of the Kitti Municipal
22 Government and the Isokohnedi of Kitti. The allottees shall be
23 responsible for ensuring that these funds, or so much thereof as may
24 be necessary, are used solely for the purposes specified in this act,
25 and that no obligations are incurred in excess of the sum



1 appropriated. The authority of the allottees to obligate funds
2 appropriated by this act shall not lapse.

3 Section 4. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its becoming
5 law without such approval.
