A BILL FOR AN ACT

To amend Public Law No. 6-91 by amending sections 12 and 13 to shift certain previously made appropriations from the Capital account to the current account, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 12 of Public Law No. 6-91 is hereby amended  
2 to read as follows:

3 "Section 12. Other National Government programs, grants,  
4 subsidies, contributions, and refunds. The sum of  
5 ~~\$3,232,673~~ 4,232,673, or so much thereof as may be  
6 necessary, is hereby appropriated from the General Fund of  
7 the Federated States of Micronesia for the fiscal year  
8 ending September 30, 1991, for special programs, grants,  
9 subsidies, contributions, and refunds of the National  
10 Government of the Federated States of Micronesia during  
11 fiscal year 1991. The sum appropriated by this section  
12 shall be apportioned as follows:

21 Section 2. Section 13 of Public Law No. 6-91 is hereby amended  
 22 to read as follows:


23 "Section 13. Development budget - Appropriation. The sum  
 24 of ~~\$2,610,000~~ 1,610,000, or so much thereof as may be  
 25 necessary, is hereby appropriated from the General Fund of

1 the Federated States of Micronesia for the fiscal year  
 2 ending September 30, 1991, for capital improvement and  
 3 development programs and projects of the National  
 4 Government of the Federated States of Micronesia during  
 5 fiscal year 1991. The funds appropriated under this  
 6 section shall be deemed to come from the capital account of  
 7 the Compact of Free Association. The sum appropriated by  
 8 this section shall be apportioned as follows:

- 9 (1) National staff upgrading..... \$ 75,000
- 10 (2) Business and Tourism Promotion..... 35,000
- 11 (3) Business development loan fund..... ~~2,200,000~~ 1,200,000
- 12 (4) Poultry processing & packaging project:
- 13 (a) Kosrae..... 75,000
- 14 (b) Yap..... 85,000
- 15 (c) Chuuk..... 140,000"

16 Section 3. This act shall become law upon approval by the President  
 17 of the Federated States of Micronesia or upon its becoming law without  
 18 such approval.
