A BILL FOR AN ACT

To amend sections 1 and 3 of Public Law No. 6-88 to reallocate certain funds previously appropriated for public projects in the Mortlocks Islands of Chuuk State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-88 is hereby amended  
2 to read as follows:

3 "Section 1. The sum of \$93,000, or so much thereof as may  
4 be necessary, is hereby appropriated from the General Fund  
5 of the Federated States of Micronesia for the fiscal year  
6 ending September 30, 1990, for the purpose of funding  
7 public projects in the Upper Mortlocks area of the  
8 Mortlocks Islands of Chuuk State. The sum appropriated  
9 by this section shall be apportioned as follows:

7           "Section 3. The sum of \$125,000, or so much thereof as may  
 8           be necessary, is hereby appropriated from the General Fund  
 9           of the Federated States of Micronesia for the fiscal year  
 10          ending September 30, 1990, for the purpose of funding  
 11          public projects in the Lower Mortlocks area of the Mortlocks  
 12          Islands of Chuuk State. The sum appropriated by this  
 13          section shall be apportioned as follows:
