A BILL FOR AN ACT

To further amend Public Law No. 6-49, as amended by Public Law No. 6-55, by further amending sections 1 and 10, as amended by Public Law No. 6-55, to change the use of funds appropriated thereunder, and to designate an allottee for a new project, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 6-49, as amended by
2 Public Law No. 6-55, is hereby further amended to read as follows:

3 "Section 1. Statewide public projects. The sum of
4 \$200,000, or so much thereof as may be necessary, is hereby
5 appropriated from the General Fund of the Federated States
6 of Micronesia for the fiscal year ending September 30,
7 1990, for the purpose of funding certain statewide public
8 projects in Chuuk State. The sum appropriated by this
9 section shall be apportioned as follows:

- 10 (1) School buses..... ~~\$75,000~~ 60,000
- 11 (2) TOCA - Rural water system..... 22,000
- 12 (3) UFO School - Fefan..... 15,000
- 13 (4) ,Library - Mortlocks Jr. High
- 14 School..... 20,000
- 15 (5) Farmers Home Administration -
- 16 Chuuk Office..... 6,000
- 17 (6) Weno Constitutional Convention... 10,000
- 18 (7) Chuuk Federation of Fishing
- 19 Co-op..... 7,000
- 20 (8) Chuuk Visitors Bureau -
- 21 Tourist promotion..... 10,000
- 22 (9) Chuuk Hospital water tank..... 15,000
- 23 (10) Chuuk recreational activities.... 10,000
- 24 (11) Lukunor Copra Co-op Association.. 10,000
- 25 (12) Peace Corps housing allowance.... 15,000"

1 Section 2. Section 10 of Public Law No. 6-49, as amended by
2 Public Law No. 6-55, is hereby further amended to read as follows:
3 "Section 10. Allotment and management of funds and lapse
4 date. All funds appropriated by this act shall be
5 allotted, managed, administered, and accounted for in
6 accordance with applicable law, including, but not limited
7 to, the Financial Management Act of 1979. The allottee of
8 the funds appropriated by section 4 of this act shall be
9 the President of the Federated States of Micronesia. The
10 allottee of the funds appropriated by subsection (2) of
11 section 1 of this act shall be the Truk Organization of
12 Community Action (TOCA); the allottee of the funds
13 appropriated by subsection (4) of section 1 shall be the
14 Lower Mortlocks Development Authority; and the allottee of
15 the funds appropriated by subsections (1), (3), (5), (6),
16 (7), (8), (9), (10), ~~and~~ 11 and 12 of section 1 shall be
17 the Governor of Chuuk State. The allottees of the funds
18 appropriated by sections 2, 3, 5, 6, 7, 8 and 9 of this act
19 shall be the local development authorities of the areas for
20 which the projects are designated. The allottees shall be
21 responsible for ensuring that these funds, or so much
22 thereof as may be necessary, are used solely for the
23 purposes specified in this act, and that no obligations are
24 incurred in excess of the sum appropriated. The authority
25 of the allottees to obligate funds appropriated by this act

1 shall not lapse until expended."

2 Section 3. This act shall become law upon approval by the
3 President of the Federated States of Micronesia or upon its becoming
4 law without such approval.
