Public Law No. 6 - 46

AN ACT

To amend Public Law No. 6-10 by amending section 2 for the purpose of appropriating the sum of \$457,673 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1990, as supplemental funding for the legislative branch, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1            Section 1. Section 2 of Public Law No. 6-10 is hereby amended  
2 to read as follows:

3            "Section 2. Operating expenses of the legislative branch.

4            The sum of \$2,615,873, or so much thereof as may be  
5 necessary, is hereby appropriated from the General Fund of  
6 the Federated States of Micronesia for the fiscal year  
7 ending September 30, 1990, for the operations of the  
8 legislative branch of the National Government of the  
9 Federated States of Micronesia during fiscal year 1990.  
10            As required by Pubic Law No. 5-119, the Congress of the  
11 Federated States of Micronesia hereby declares that the  
12 funding appropriated by this section is deemed to be  
13 essential. The sum appropriated by this section shall be  
14 apportioned as follows:

- 15            (1) Office of the Speaker and Members
  - 16                    (a) Personnel expenses..... \$ 400,100
  - 17                    (b) Travel..... 381,400
  - 18                    (c) Contractual services,  
19 grants, subsidies, and contributions..... 136,800
  - 20                    (d) Others..... 50,000
- 21            (2) Staff Offices
  - 22                    (a) Personnel expenses..... 718,635


