Public Law No. 7 - 107

AN ACT

To appropriate the sum of \$6,400,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, of which amount \$5,000,000 shall be deemed to come from the capital account of the Compact of Free Association, for the purpose of purchasing equity in certain longline fishing joint ventures in the States of Chuuk and Kosrae, for the purpose of purchasing equity in Yap Fresh Tuna Incorporated, and for the purpose of providing additional operating capital to the Caroline Fisheries Corporation; for the purpose of funding small-scale fishing projects in Chuuk State; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. The sum of \$5,800,000, or so much thereof as may be
- 2 necessary, is hereby appropriated from the General Fund of the
- 3 Federated States of Micronesia for the fiscal year ending September
- 4 30, 1993, to the National Fisheries Corporation for the purpose of
- 5 purchasing equity in certain longline fishing joint ventures in the
- 6 States of Chuuk and Kosrae; to the State of Yap for the purchase of
- 7 equity in Yap Fresh Tuna Incorporated; to the Caroline Fisheries
- 8 Corporation for the purpose of providing additional operating
- 9 capital; and to the State of Kosrae for the purpose of purchasing
- 10 equity in a longline fishing joint venture in the State of Kosrae.
- 11 From the funds appropriated under this section, \$5,000,000 shall be
- 12 deemed to come from the capital account of the Compact of Free
- 13 Association.
- 14 Section 2. The sum appropriated under section 1 of this act
- 15 shall be apportioned as follows:
- 16 (1) Equity purchase in Chuuk Fresh Tuna Incorporated;
- 17 provided, none of the funds appropriated under this subsection may be
- 18 expended for the acquisition of land; and provided further, none of
- 19 the funds appropriated under this subsection may be expended for any
- 20 purpose until after land with a clear title has been obtained for

6	Section 4. All funds appropriated by this act shall be			
7	allotted, managed, administered, and accounted for in accordance with			
8	applicable law, including, but not limited to, the Financial			
9	Management Act of 1979. The allottee of the funds appropriated under			
10	section 1 of this act shall be the President of the Federated States			
11	of Micronesia or his designee. The allottee of the funds			
12	appropriated under subsection (1) of section 3 of this act shall be			
13	the Faichuk PWP Authority. The allottee of the funds appropriated			
14	under subsections (2), (3), (4) and (5) of section 3 of this act			
15	shall be the Chuuk Organization of Community Agencies. The allottees			
16	shall be responsible for ensuring that these funds, or so much			
17	thereof as may be necessary, are used solely for the purposes			
18	specified in this act, and that no obligations are incurred in excess			
19	of the sum appropriated. The authority of the allottees to obligate			
20	funds appropriated by this act shall not lapse.
