AN ACT

To further amend Public Law No. 7-78, as amended by Public Laws Nos. 7-80, 7-111, and 7-113, by further amending section 5, as amended by Public Law No. 7-80, to appropriate the sum of \$37,825 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, to provide additional funding for the National Postal Service and for the operating expenses of the Board of Regents of the College of Micronesia, and for other purposes.
