CONGRESSIONAL BILL NO. 7-152

AN ACT

To further amend Public Law No. 6-49, as amended, by further amending sections 6 and 10, as amended by Public Laws Nos. 6-55, 6-96, 6-112, 7-3 and 7-18, to modify the use of certain funds appropriated therein for public projects in the Pattiw, Weito, and Hall Islands of Chuuk State and to change the allottee of certain funds, and for other purposes.

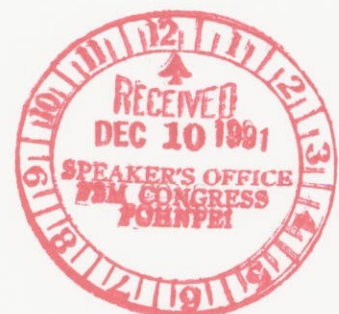
BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 6 of Public Law No. 6-49, as amended by Public
2 Laws Nos. 6-55, 6-112, 7-3 and 7-18, is hereby further amended to read
3 as follows:

4 "Section 6. Pattiw, Weito, and Hall Islands public projects.

5 The sum of \$240,000, or so much thereof as may be necessary,
6 is hereby appropriated from the General Fund of the Federated
7 States of Micronesia for the fiscal year ending September 30,
8 1990, for the purpose of funding certain public projects in
9 the Pattiw, Weito, and Hall Islands, Chuuk State. The sum
10 appropriated by this section shall be apportioned as follows:

11 (1) Puluwat public projects.....	\$ 20,000
12 (2) Onoun medicine, food and clothing,	
13 and freight costs of typhoon relief goods.....	20,000
14 (3) Nomwin medicine, food and clothing,	
15 and freight costs of typhoon relief goods.....	20,000
16 (4) Lien Pisarach operation and maintenance...	13,124
17 (5) Ruo medicine, food and clothing,	
18 and freight costs of typhoon relief goods.....	19,000
19 (6) Makur medicine, food and clothing,	
20 and freight costs of typhoon relief goods.....	7,000
21 (7) Tamatam medicine, food and clothing,	
22 and freight costs of typhoon relief goods.....	15,000



1 (8) Murilo medicine, food and clothing,
2 and freight costs of typhoon relief goods..... \$19,000
3 (9) Ono medicine, food and clothing,
4 and freight costs of typhoon relief goods..... 7,000
5 (10) Onari medicine, food and clothing,
6 and freight costs of typhoon relief goods..... 7,000
7 (11) Pollap medicine, food and clothing,
8 and freight costs of typhoon relief goods..... 19,000
9 (12) Fananu medicine, food and clothing,
10 and freight costs of typhoon relief goods..... 19,000
11 (13) Pulusuk public projects..... 19,000
12 (14) Weito Authority..... 10,000
13 (15) Hall Authority..... 10,000
14 (16) Pattiw Authority..... 10,000
15 (17) Hall Islands Advisory Council..... 5,876"
16 Section 2. Section 10 of Public Law No. 6-49, as amended by
17 Public Laws Nos. 6-55, 6-96, 6-112 and 7-3, is hereby further amended
18 to read as follows:
19 "Section 10. Allotment and management of funds and lapse
20 date. All funds appropriated by this act shall be allotted,
21 managed, administered, and accounted for in accordance with
22 applicable law, including, but not limited to, the Financial
23 Management Act of 1979. The allottee of the funds appro-
24 priated by sections 4, 6(2), 6(3), 6(5), 6(6), 6(7),
25 6(8), 6(9), 6(10), 6(11), 6(12) and 6(13) of this act shall



1 be the President of the Federated States of Micronesia. The
2 allottee of the funds appropriated by subsection (2) of
3 section 1 of this act shall be the Truk Organization of
4 Community Action (TOCA); the allottee of the funds appro-
5 priated by subsection (4) of section 1 shall be the Lower
6 Mortlocks Development Authority; and the allottee of the
7 funds appropriated by subsections (1), (3), (5), (6), (7),
8 (8), (9), (10), and (11) of section 1 and by section 2 shall
9 be the Governor of Chuuk State. The allottee of the funds
10 appropriated under subsection (12) of section 1 of this act
11 shall be the Peace Corps Representative, Chuuk State. The
12 allottees of the funds appropriated by sections 3, 5, 6(1),
13 6(4), 6(14), 6(15), 6(16), 6(17), 7, 8 and 9 of this act
14 shall be the local development authorities of the areas for
15 which the projects are designated. The allottees shall be
16 responsible for ensuring that these funds, or so much
17 thereof as may be necessary, are used solely for the
18 purposes specified in this act, and that no obligations are
19 incurred in excess of the sum appropriated. The authority
20 of the allottees to obligate funds appropriated by this act
21 shall not lapse until expended."

2 President of the Federated States of Micronesia or upon its becoming
3 law without such approval.
