AN ACT

To appropriate the sum of \$3,300,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1992, for the purpose of funding public projects in the State of Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Statewide public projects. The sum of \$400,000, or
2 so much thereof as may be necessary, is hereby appropriated from the
3 General Fund of the Federated States of Micronesia for the fiscal
4 year ending September 30, 1992, for the purpose of funding statewide
5 public projects in the State of Chuuk. The sum appropriated by this
6 section shall be apportioned as follows:

21 Section 2. Northern Namoneas public projects. The sum of
22 \$515,000, or so much thereof as may be necessary, is hereby



1 appropriated from the General Fund of the Federated States of
2 Micronesia for the fiscal year ending September 30, 1992, for the
3 purpose of funding public projects in Northern Namoneas, Chuuk State.
4 The sum appropriated by this section shall be apportioned as follows:

1 Section 3. Southern Namoneas public projects. The sum of
2 \$595,000, or so much thereof as may be necessary, is hereby
3 appropriated from the General Fund of the Federated States of
4 Micronesia for the fiscal year ending September 30, 1992, for the
5 purpose of funding public projects in Southern Namoneas, Chuuk State.

6 Section 4. Faichuk public projects. The sum of \$690,000, or so
7 much thereof as may be necessary, is hereby appropriated from the
8 General Fund of the Federated States of Micronesia for the fiscal
9 year ending September 30, 1992, for the purpose of funding public
10 projects in Faichuk, Chuuk State.

11 Section 5. Mortlocks public projects. The sum of \$525,000, or
12 so much thereof as may be necessary, is hereby appropriated from the
13 General Fund of the Federated States of Micronesia for the fiscal
14 year ending September 30, 1992, for the purpose of funding public
15 projects in the Mortlocks Islands, Chuuk State. The sum appropriated
16 by this section shall be apportioned as follows:

17 (1) Municipal Constitutional Convention
18 activities..... \$225,000
19 (2) Other public projects..... 300,000

20 Section 6. Pattiw, Weito, and Hall Islands public projects.
21 The sum of \$400,000, or so much thereof as may be necessary, is
22 hereby appropriated from the General Fund of the Federated States
23 of Micronesia for the fiscal year ending September 30, 1992, for the
24 purpose of funding public projects in the Pattiw, Weito, and Hall
25 Islands, Chuuk State. The sum appropriated by this section shall be

6 Section 7. Other Chuuk State public projects. The sum of
7 \$175,000, or so much thereof as may be necessary, is hereby
8 appropriated from the General Fund of the Federated States of
9 Micronesia for the fiscal year ending September 30, 1992, for the
10 purpose of funding other public projects in Chuuk State. The sum
11 appropriated by this section shall be apportioned as follows:
12 (1) Southern Namoneas Development Authority..... 15,000
13 (2) Southern Namoneas tourism promotion
14 pamphlets..... 20,000
15 (3) Saramen Chuuk Academy for secular educational
16 purposes..... 140,000
17 Section 8. All funds appropriated by this act shall be
18 allotted, managed, administered, and accounted for in accordance with
19 applicable law, including, but not limited to, the Financial
20 Management Act of 1979. The allottee of the funds appropriated under
21 section 1 of this act shall be the Governor of Chuuk State; the
22 allottee of the funds appropriated under subsections (1), (2), (3),
23 (5), (6), (7), (8), (9), (10), (11) and (12) of section 2 of this act
24 shall be the Mayor of Weno Municipality; the allottee of the funds
25 appropriated under subsection (4) of section 2 of this act shall be

1 the Mayor of Fono Municipality; the allottee of the funds
2 appropriated under sections 4 and 5(2) of this act shall be the
3 President of the Federated States of Micronesia; the allottee of the
4 funds appropriated under sections 5(1) and 6 shall be the local
5 development authorities of the areas for which the funds are
6 designated; the allottee of the funds appropriated under sections 3
7 and 7 of this act shall be the Southern Namoneas Development
8 Authority. The allottees shall be responsible for ensuring that
9 these funds, or so much thereof as may be necessary, are used solely
10 for the purposes specified in this act, and that no obligations are
11 incurred in excess of the sums appropriated. The authority of the
12 allottees to obligate funds appropriated by this act shall not lapse.
13 Section 9. This act shall become law upon approval by the
14 President of the Federated States of Micronesia or upon its becoming
15 law without such approval.


