CONGRESSIONAL BILL NO. 7-359

Public Law No. 7 - 80

AN ACT

To amend Public Law No. 7-78 by amending section 5 to appropriate the sum of \$59,445 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 1993, to provide funding for the operating expenses of the Board of Regents of the College of Micronesia, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

Section 1. Section 5 of Public Law No. 7-78 is hereby amended to 1 read as follows: 2 "Section 5. Operating expenses of agencies of the National 3 Government. The sum of \$1,216,195, or so much thereof as may be necessary, is hereby appropriated from the General 5 Fund of the Federated States of Micronesia for the fiscal 6 year ending September 30, 1993, for the operations of 7 independent agencies, commissions, authorities, boards, bureaus, and other organizations of the National Government 9 of the Federated States of Micronesia during fiscal year 10 1993. The sum appropriated by this section shall be 11 apportioned as follows: 12 (1) Micronesian Maritime Authority 13 (a) Personnel expenses\$162,900 14 (b) Travel 90,000 15 (c) Contractual services, grants, 16 subsidies, and contributions 62,400 17 (d) Others 40,700 18 (e) Observers on fishing boats 19 (i) Personnel expenses 30,000 20 (ii) Travel 25,000 21
