A RESOLUTION

Officially naming the Nahs or traditional meeting house of the Congress of the Federated States of Micronesia the Honorable Tony Otto Nahs.

- 1 WHEREAS, the Honorable Tony Otto was elected to the Third
- 2 Congress in 1983 from the Fifth Congressional District in Chuuk,
- 3 which includes the Hall and Western Islands and served with
- 4 distinction as Vice Chairman of the Resources and Development
- 5 Committee; and
- 6 WHEREAS, the Honorable Tony Otto served with distinction as the
- 7 Chairman of the Committee on Health, Education and Social Affairs in
- 8 the Fourth Congress; and
- 9 WHEREAS, the Honorable Tony Otto served with distinction as a
- 10 member of the Judiciary and Governmental Operations Committee and the
- 11 Health, Education and Social Affairs Committee in the Fifth Congress;
- 12 and
- 13 WHEREAS, the Honorable Tony Otto served with distinction as
- 14 Chairman, and later Vice Chairman, of the Committee on Ways and Means
- 15 in the Sixth Congress; and
- 16 WHEREAS, the Honorable Tony Otto was a conciliator during his
- 17 long and distinguished career in the Congress, bringing together
- 18 diverse interests and personalities and thereby greatly facilitating
- 19 the important work of the Congress; and
- WHEREAS, the purpose of a traditional meeting house or nahs is
- 21 to bring the community together and to create an atmosphere of
- 22 cooperative decision making, and thus it is fitting and proper that
- 23 the nahs of the Congress be named after the Honorable Tony Otto; now,
- 24 therefore,
- 25 BE IT RESOLVED by the Seventh Congress of the Federated States

- 2 meeting house or nahs constructed for the Congress be hereby
- 3 officially named the Honorable Tony Otto Nahs, in tribute to Senator
- 4 Otto's distinguished service to the Congress and the people of the

- 6 BE IT FURTHER RESOLVED that a plaque bearing the following
- 7 inscription be permanently affixed on the outside of the structure of
- 8 the nahs: "The Honorable Tony Otto Nahs, In Recognition of his
- 9 Distinguished Service to the Congress and the People of the Federated
- 10 States of Micronesia"; and
- 11 BE IT FURTHER RESOLVED that certified copies of this resolution
- 12 be transmitted to the Speaker of the Congress of the Federated States
- 13 of Micronesia, the President of the Federated States of Micronesia,
- 14 the Chief Justice of the Supreme Court of the Federated States of

15 Micronesia and the Honorable Tony Otto.
